April Town Council Meeting – Wednesday, April 3, 7:30 p.m.

Two important topics will be presented.

“What bugs you?” could well be the topic for our next community meeting. David Kellum, the San Diego County entomologist, will be speaking about area pests (those with more than two legs), and will be bringing handouts for you (maybe he will bring samples of fire ants as well - dead, we hope).

Preserving habitat is an important priority and helps to keep our community rural. The efforts of the surrounding cities to preserve habitat affect Elfin Forest as well, so we will also hear from Janet Fairbanks who will give an overview of the multiple habitat conservation program (MHCP) which involves 7 cities and an undefined 500 acres in the western Elfin Forest area.

E.F. Community Foundation Election Rescheduled

Because of our lack of organization, we are re-scheduling the election of three board members until April's Town Council meeting. We are including another ballot in this issue of the Chaparral, and have given each candidate a chance to submit a short candidate statement.

It's a first. We actually have more people willing to serve on the Community Foundation Board than we have slots available. Way to go Elfin Forest! So, we've had to hold over the elections until this month's Town Council meeting to get adequately prepared. (Can you say ballot box?) In the past, when we had 3 seats open and 3 candidates running, even I could determine the winners. So apologies to any and all who attempted to vote. Here's the new procedure:

Voting Instructions

1. "Walk in" voters at the meeting must first check-in at a desk where their address and name will be noted and checked off on a list of CSA107 residents and property owners.
2. Mailed in ballots must be in an envelope having a name, address and signature on the back for each ballot in the envelope – better yet, only one ballot per envelope. The envelopes would be used to mark up the resident listing. If someone mails in a ballot envelope AND votes at the meeting the ballot envelope is nullified.

Secrecy can be preserved if the ballot slip inside the envelope is folded and simply removed from the envelope and dropped into the ballot box, still folded, once the name and address have been validated on the envelope.

Candidates' Statements

JOE ALEMANNI

My wife, Evelyn and I have lived in Elfin Forest for 14 years. We were among the people who were instrumental in getting the city of San Marcos to set aside a portion of the tipping fees from the San Marcos Landfill for the benefit of Elfin Forest residents because Elfin Forest was impacted by the landfill while San Marcos residents weren't. These funds later became the initial funding for the EFCF.

I'm a self-employed consulting software engineer and have taken on the job of producing this newsletter until our editor, David Cronshaw recovers from an illness. I believe that the foundation assets belong to the entire community and that all grant application meetings should be publicly noticed and open to all residents. I believe that grant applications should be made verbally, as well as in writing, so that board members have the opportunity to ask questions and residents can understand the nature of the grants that are applied for. Grants should be audited and receipts be presented to assure that community funds are spent for the projects for which they were allocated.

BETSY KEITHLEY

I have been an Elfin Forest resident since 1985. I have served on the Fire Department as a firefighter and Lieutenant, on the Fire Advisory Board and the Town Council, as secretary, and on the Escondido Creek Conservancy Board. I was an editor of the Community Guide, 1997 edition. The Community Foundation is one of our greatest assets (the election is competitive!) and my objective as a board member will be to raise the community's awareness of this asset. Goals and objectives of the Foundation should be established and published in the Chaparral. Each award should be announced in the Chaparral. Every community member should be aware of the grant application and review process. Elections should be held every year. This is a Community Foundation and there should be community participation.

MARTHA BLANE (Incumbent)

Martha has lived in Elfin Forest, on Fortuna del Este, since 1982. She was a founding board member of The Escondido Creek Conservancy and served as its first president. She has been on the Elfin Forest Community Foundation board since its inception and has served on the Elfin Forest Town Council. Martha and her husband raised two children in EF and were voted Citizens of the Year in 1995. She has supported preserving a rural way of life in EF, assisted with various tree planting projects and worked for land/open space preservation in the region. For a livelihood she provides consulting services for habitat restoration of endangered species.

TREY FAIRMAN (Incumbent)

In over four years as a resident of Elfin Forest, my appreciation of the surrounding beauty has grown

with each passing season. During the same period, my distaste for the encroaching suburbia has dramatically increased. Our community is truly unique and needs to be protected. As a Director of the Elfin Forest Community Foundation, my goal has been to preserve and enhance our native California rural environment.

If elected, I will focus my attention on preserving the native beauty found in our valley. To me this means restoring the native chaparral and live oak habitats when and where appropriate while encouraging beautification projects within our community. Along with my continued support of an expanding horse trail system, I will propose nesting box programs to promote and boost the population of Bluebirds, Barn Owls, and American Kestrels in Elfin Forest.

MIKE VALLEE (incumbent)

Elfin Forest resident since 1991. Currently treasurer of the EFCF. One of the founding members of the foundation and has served since it's inception in 1994. Negotiated transfer of the initial principal from the City of San Marcos and it's City Attorney. Organized the benefit dance at Stagecoach Gym to benefit our firefighters following the Harmony Grove tragedy, on behalf of the Foundation. Works as a trial lawyer in Solana Beach and lives on Elfin Forest Lane with wife Becky and his son, Bryce.

PATTI NEWTON

Patti Newton has been involved with community issues over the last several years. She's served on the town council (currently Secretary) and on board of The Escondido Creek Conservancy. Her various political activities and commitment to preserving the lifestyle we all enjoy is strong and would be well suited to the duties associated with serving on the board of the Elfin Forest Community Foundation.

MINUTES OF ELFIN FOREST/HARMONY GROVE TOWN COUNCIL MEETING

DATE: March 6, 2002
BOARD MEMBERS PRESENT: Bill Telesco, Evelyn Alemanni, Patti Newton, Linda Hamilton, Mid Hoppenrath, Nancy Reed, Eric Anderson, Alan Lasnover
CALL TO ORDER: 7:35 p.m.

ITEM #1: **Evelyn Alemanni** thanked those who supported Kevin Barnard's campaign for County Supervisor. The campaign, remarkably, closed without debt after raising an astounding \$41,000 in sixty days. Statistically, each of Kevin's votes cost him about \$1.99, Bill Horn's about \$6, and Patsy Fritz's cost about \$7 each! A popular grassroots candidate, Kevin only needed about 1,000 more votes to qualify for a runoff in November.

Mid Hoppenrath announced there will be a public workshop on Quail Hills (power plant project) on March 11, 6:30 p.m. at Escondido City Hall.

Nancy Reed, a member of the San Dieguito Planning Group, stated the Michael Garrison project may be required to prepare an EIR although it is early in the process. The EIR for Cielo del Norte is about 45 to 60 days away from distribution.

Frank Oddo, a member of the Elfin Forest Landscape Foundation, presented the first street name plaque. Artists, Jennifer and Charles Coburn unveiled the gorgeous 3' x 2' steel plate for Elfin Glen. A new rock contractor (Earl Powers Construction) will be constructing the monuments over the next few weeks. Two streets will not have monuments because of visibility issues and water easements; it is likely that large boulders with mounted plaques will be used. Illustrative photos were distributed among residents who gave approval. Boulders with plaques displaying street addresses will be installed for those streets without names. Mulch will be provided by North Coast Arborists. Streets south of the fire department should be completed by the end of the month.

Elfin Forest Landscape Foundation statistics to date: One mile of fence line installed; 3,500' of irrigation installed; 250 Pepper trees planted; 15 Oaks planted; 1,600 man hours expended since January 1.

ITEM #2: **Olivenhain Municipal Water District** updates on reservoir project. **Jerry Reed**, of the SDCWA, Rebecca Cole, OMWD community relations, Sarah Connelly, Harry Erlich, project manager, and Alex Newton, field representative, were all on hand to provide information and answer questions.

Kiewit is on schedule with the 24-hour roller-compacted concrete operations (target completion date April, 2003). Truck traffic will resume March 12, from 7 a.m. to 4 p.m.

Approximately 58 trucks per day will use Harmony Grove Road. Safety measures have been taken, including sending letters out to bicycle groups and to their own truck drivers. Deliveries to the site can be made after 7 a.m.. The engineer has assured no deliveries will be made before that hour. To date, the OMWD has fined subcontractors to the tune of \$25,000 for various infractions. Speed bumps (modified to minimize noise) have been installed on Via Ambiente at the intersection with Harmony Grove Road to control speed of trucks exiting. Noise monitoring has been conducted and found to be less than expected. The rock crusher bins have been lined with rubber to minimize sound. Ongoing dust control measures are in place. Improved signage for trucks has been installed (to minimize U-turn activity). Cameras monitor the movement of trucks within the project. **Alex Newton** is available to discuss residents' concerns relative to safety issues.

ITEM #3: **Meredith Keene**, San Diego Medical Service Enterprises (CSA 17) discussed the paramedic services it provides for CSA 107. Our fire department personnel provide "first responder" services to those in need, while CSA 17 provides paramedic services. They can and will conduct health and safety classes designed to address the particular concerns in a given area, i.e., snakebite first aid, drowning prevention, etc., if residents are inclined to avail themselves of the opportunity. A tentative class time was scheduled for April 20, 8 a.m. to 11 a.m..

ITEM #4: **Jim Flood**, The Brehm Companies, represents the company in escrow with Max Altmann on the former Pulte Homes project, now known as San Elijo Ridge. Escrow is slated to close sometime in August, assuming the developer wants to move forward on the project after some due diligence. Brehm is a 35-year old San Diego based builder that has been involved with projects in Aviara, Murieta, and Riverside. It plans to proceed with the project as currently proposed and won't begin construction until the Questhaven Road improvements have been made. The tentative map should be approved this July.

ITEM #5: **Frank Twohy** stated that Via de las Flores will be closed March 13th and 14th from 9 a.m. until 1 p.m. Additionally, traffic will be controlled from March 7th through March 15th. There has been some dissatisfaction regarding the installation of speed bumps on private roads that fail to meet county code specifications. Negotiating these bumps costs fire dept. personnel a significant amount of valuable response time; the fire dept. will see that these bumps are brought up to code.

Observations from the Edge

The North County Times

Last week (March 5) only 29 percent of the registered voters in North County took time to participate in the governance of their lives. When did big "D" in democracy become so unimportant?

Supervisor Bill Horn was not reelected to office by a ground swell of popular support. Of the 545,865 people living in the 5th District, and 252,256 votes possible, only 97,983 ballots were cast, of which Mr. Horn received 42,387. Once the math is done, one sees that an approximate 7.8 percent minority elected the official that will set the agenda for the next four years. Sixty one percent, a sizable majority, of those who could have voted didn't. Perhaps this is what is meant by the term silent majority.

Of the 39% who did vote, 47 % of those voted for someone other than Bill Horn. So it is nothing more than a linguistic slight of hand to say the District 5 supervisor race was won with a majority vote. In reality 86 % percent of those who could have punched a chad for the Supervisor didn't. Perhaps this is why the Supervisor bills himself on his website as "the bottom line in leadership." To say Bill Horn was once again elected by a narrow special interest group would not be unreasonable, considering most of Supervisor Horn's campaign contributions have come from development over the course of his political life. Is it any wonder that everyone sits in near gridlock because growth is outpacing sustainable planning and infrastructure construction?

These numbers show that because of the collective apathy of eligible voters, all it takes is a small margin to get elected and thus set the regional agenda without a public mandate to do so. In the case of Supervisor Horn, and those that supported his reelection, their agenda is one that embraces the "Growth at all costs" philosophy, without any consideration of the environmental consequences evidenced in our diminishing quality of life.

Low voter turnout can also be interpreted as tacit acceptance of the status quo. If this is the case, one could only surmise Southern Californians consider overpopulation, resource depletion, groundwater pollution, and habit destruction as wise civic governance.

News About the Derbas Property in Harmony Grove

An important link in North County's habitat conservation effort could be established thanks to the efforts of local town councils working together with third district county supervisor, Pam Slater. With her leadership, the board of supervisors approved the county to look closely at purchasing the environmentally strategic Derbas property. This 342-acre site has a willing seller who wants to see the property maintained as permanent open space. The land, home to the endangered plant *Encinitas baccharis*, is adjacent to the Elfin Forest reserve and connects with Lake Hodges.

Weeds can be a fire hazard, and they're expensive to get rid of – Roundup costs about \$100 per gallon, and if you don't catch the weeds soon enough, you may end up paying a laborer for several days to get the weedwacking done. But here are two simple solutions that organic gardeners swear by. The first is boiling water. This is a great spot treatment, but not practical for large areas. For spraying, a solution of 4 parts vinegar and 1 part lemon juice is said to show results in only two hours.

Creek Happenings: On the Grants Front

A \$9,500 grant application written by TECC volunteer, Martha Blane, was funded by the Charles H. Stout Foundation in June 2001. These funds will be used to purchase equipment, supplies, signs, and services for a volunteer habitat enhancement project to remove exotic/non-native plants from the non-wetland portions of the Escondido Creek Preserve. The 97-acre TECC-owned preserve consists of two parcels; the 76-acre parcel adjacent to the Elfin Forest Recreational Reserve (EFRR) and a 21-acre parcel located approximately three miles downstream. The project will remove invasive non-native plants (primarily eucalyptus, cape ivy, castor bean, fennel, arundo and tree tobacco) that are competing with and choking out native vegetation that provides habitat for wildlife. TECC's project will be similar to exotics removal conducted upstream at the EFRR by the Olivenhain Municipal Water District (OMWD).


TECC's habitat enhancement project will be conducted in the non-wetland portions of the preserve. The wetland portions are not included in this volunteer project since they require planning and permitting by local and state agencies before enhancement can be implemented. However, removal of exotics adjacent to the wetland areas reduces further invasion into wetland areas.


The equipment TECC will purchase using Stout grant money will be used for years to come as TECC continues its work restoring and preserving native habitat within the Escondido Creek watershed. In February, staff obtained a grant from the San Diego Stream Team that will fund chemical testing supplies and training to start this additional water quality testing program on Escondido Creek. Also, TECC will purchase additional equipment to enhance its benthic macroinvertebrate (bug) collecting to monitor the health of the creek. The shopping list includes such items as a densitometer to measure creek canopy cover, a laser level to measure creek gradient, and a digital camera for recording physical habitat. Additional essentials like hip waders, and Leki hiking poles (necessary for safety on rugged trails and fording the creek). "Life-saving" Leki poles have previously been loaned by generous TECC member, Dr. Betsy Keithley. Thanks a million, Betsy!

In partnership with the San Elijo Lagoon Foundation, TECC submitted an Urban Streams Restoration grant in March. Staff also wrote a small grant for land acquisition through the Wetlands Recovery Project. Grant recipients will be notified this spring. TECC is excited about the possibility of working on these projects. Look for news about these highly competitive grants and keep your fingers crossed!

county. There's a lot of very interesting information
there! Note: the data displays better if you use
Explorer rather than Netscape.

Start by going to cart.sandag.cog.ca.us/redi/ and click
on Get REDI v2.0. Next, click on Locate, type in
your address, and a map of your house location will
appear. Now click on Report, then select Statistical
Summary, then click on your address on the map, and
voila, your stats appear.

Once on the site, you can subscribe to an e-mail
newsletter that will keep you abreast of what's new
on the Web site based on your particular areas of
interest.

One feature on the site is an interactive mapping
program that allows you to plug in your address and
retrieve a statistical snapshot of your immediate
neighborhood that includes population, ethnic and
racial background, employment information and
household income.
